Corporate Head Tax

Large corporations make use of our schools, streets, and city services. Before 2012, they paid for this infrastructure with a monthly fee for every employee. It's time to bring it back.



PILOT Program

Billions of dollars of valuable downtown property is exempted from property taxes every year--which means renters and property owners make up the difference. A PILOT (Payment in Lieu of Taxes) program would ask the institutions that benefit from these exemptions to contribute back to their communities.



TIF Surplus

Money shouldn't be going to developers like Sterling Bay, it should be going to our communities and our schools. This legislation declares a surplus to return the money to our neighborhoods.



Real Estate Transfer Tax

Increasing the tax on highend properties over \$1M could bring in over \$100M a year to fund homelessness & affordable housing programs
